Williams encouraged all Camp members to volunteer as guides for our Flint counterparts should they accept another invitation.

XII. Good of the Order:

Bro. Harrison reminded the Camp of the Weekend of Remembrance at the Michigan Veteran's Facility in Grand Rapids, MI on August 7 and 8. There is to be a new "Lincoln" speaker for the ceremony. On Saturday there is a free ice cream social, pig roast, and dance with live music for attendees.
