IV. Approval of Minutes:

Camp Council:

Bro. Laverne Aves summarized the findings of the November 1, 2001 meeting. It was decided to temporarily suspend the publication of the Yankee due to the time and cost constraints imposed on our editor,

Hall Restoration:

Bro. Laverne Aves reported the costs for the porches totaled \$735.00. This being over and above the combined \$400.00 grants received, the Daughters volunteered to pay the remaining balance. There is an ongoing discussion on the need for a handicap ramp for the rear porch. Commander Lyons reported on the existence of a photograph of the original front porch. As the new porch was being built, a local resident, Ron Wells, presented Commander Lyons with a photograph depicting the original lattice weave trim on the porch. A hearty thanks goes out to Mr. Wells. +

IX. Orders and Communications:

Bro. James B. Pahl briefly reported on the 45th annual Remembrance Day ceremonies held in Gettysburg, Pennsylvania on November 17, 2001. He presented the Camp with a flag ribbon to be attached to the Camp flag guidon. He noted the services of a National Executive Director have finally been engaged.

X. Unfinished Business:

Bro. Hodges reported the date, February 23, 2002, of the upcoming Mid-Winter Conference and Lincoln/Washington Dinner in Lansing. The business portion of the day will be from 1:00 to 4:30 P.M.. Commander Lyons encouraged all to attend even though the conference is geared towards training of Camp officers.

XI. New Business:

Commander Lyons reported the date, April 20, 2002, of the Michigan Department Encampment at the Holiday Inn-West in Lansing. A change in the banquet meal is being discussed. David Finney, well-known local historian, is the guest speaker.

Bro. Calder reported on the October 13-15, 2001, Grand Ledge Days weekend. Bros. Calder and MacVean enlightened approximately 150 children over the two days they were present. Commander Lyons noted the Camp had declined to participate due to lack of support from the Camp. He encouraged all Brothers who represent the Camp at events to properly coordinate their participation through the Camp officers.

Discussion on the need for Brothers with J.V.C. – David Neese, Secretary - Thomas history demonstrations commenced.

XII. Good of the Order:

Court of Honor in Okemos interested in the presentation of the SUVCW award at their ceremony in December. He also reported on a recent lunchtime conversation regarding the recent sale of a SUVCW badge. It was suggested a SUVCW recruiting brochures and information should be circulated in businesses dealing in Civil War antiques.

XIII. Treasurer's Report:

Bro. Williams reported all Camp Sigel funds (\$348.94) were properly disbursed to the organization. The flag covers previously approved for purchase were received but are the wrong color. They have been returned to the manufacturer and reordered to our original specifications. It was recommended next year's dues of \$28.00 be received by the Treasurer by January 31, 2002 or a \$5.00 late fee be imposed. This was approved by unanimous acclimation.

Treasurer's report showed a balance of accounts at \$1,796.43 as of November 27, 2001 with \$142.00 in checking, \$673.89 in the Hall Restoration Fund, \$62.38 in the Memorial Fund, and \$918.16 in savings. Liabilities included \$259.40 earmarked for the Max O'Neil Fund. The Profit & Loss Statement for July 31, 2001 through September 25, 2001 showed total income for the period of \$34.87, total expenses of \$513.00 for net income for the period of \$(478.13).

Bro. Calder moved, seconded by Bro. Keith Harrison, to approve the Treasurer's Report as submitted. Motion carried. +

\$40.00 in donations were raised as part of "Passing the Hat".

XIV. Closing Ritual:

Commander Lyons closed the meeting per ritual at 8:35 P.M..
