III. Welcome to Guests:

Ms. Brenda Holly introduced herself her mother, Audrey, and father, Birdsill. She noted how her Union ancestor was wounded at the battle of Antietam. Bro. Lyons introduced his son-in-law, Marty Hilts, daughter, Beth Hilts, and grandson, James Hilts

IV. Approval of Minutes:

Bro. Lyons moved, seconded by Bro. Harrison, to approve of the minutes of the

May 30, 2003 meeting. Discussion was called for. No discussion was forthcoming. Motion carried.

VI. New Members and Initiations:

Bro. Lyons submitted a Junior membership application in the name of his grandson James Oliver Lyons Hilts. The application was reviewed and deemed to be in order. Bro. David Neese moved, seconded by Bro. Nash, to accept the application as presented and to elect the candidate by a voice vote. Discussion was called for. No discussion was forthcoming. Motion carried. VIII. Committee Reports: Bylaws:

Bro. Lyons reported the Bylaws Committee has completed its work. A signed copy of the bylaws is to be retained in the Camp Historian's files. Commander Shumway directed that a copy of the bylaws be distributed to all Camp members.

Memorials and Graves Registration:

Bro. Williams reported over 1,100 entries for Eaton County were entered into the Camp database a few months ago. Bro. Lyons forwarded the raw data for 2,000+ entries from Ingham County. Last names beginning with A through M have been entered into the database with N through Z to be processed before work is begun on the Barry County items. Bro. Lyons also has sketches to be scanned into the database. Commander Shumway recalled how he had seen the Department database at Charlton Park for the first time. He noted the search engine was very impressive. Volunteers will be recruited next year to survey cemeteries in order to follow-up on missing information. It was noted Bros. Lyons, Hodges, and other Camp Brothers had begun collecting cemetery data in 1986 before the database was even conceived.

Bro. Emerick reported on the upcoming dedication of a new monument on National Park Service property in Fredericksburg, Virginia. His re-enacting unit, 7th Michigan Volunteer Infantry, Co. B, raised several thousand dollars in donations for the boulder and attached bronze plaque commemorating the actions of the unit during the battle of Fredericksburg (1862).

Bro. David Neese reported the Bowen's Mills (June) and Charlton Park (July) recruiting endeavors elicited much interest from spectators. Verbal commitments were obtained from several interested parties. Mr. Holly, in attendance this evening, neglected to bring his application with him and will re-apply for membership at the September business meeting. The Sunfield Farmer's Picnic (August) and Bowen's Mills Civil War Days (October) will be our next recruiting opportunities.

Chaplain Nash presented a written report on the June Camp picnic. Bro. Hodges circulated photographs he had taken of the event. Chaplain Nash circulated images captured and forwarded to the Camp by Department SVC, Neil Breaugh.
