Keith Harrison presented and read aloud a letter informing the Camp and its Brothers that he and his wife will be including Curtenius Guard Camp No. 17 in their will as a recipient of part of the proceeds of their estate. He also presented the Camp \$200, which is the first of 5 installments totaling \$1000 to be used by the Camp for needs it deems appropriate.

#### X. Unfinished Business:

Due to the cancellation of the snowed out January meeting, the Camp still needed to nominate delegates for the Department Encampment slated for April 24<sup>th</sup> in Grand Rapids. Brothers volunteering to be delegates were Dick Williams, Michael Neese, Kyle Emerick and Tom Emerick. Discussion ensued and it was determined that the balance of camp members would be nominated as alternate delegates. Being an off schedule election, the slate of delegates was first approved by the Camp Council. Bro. Keith Harrison moved with motion seconded by Bro. Lyons, that the slate of delegates be approved as determined by the Camp Council. Motion carried.

# XI. New Business:

Bro. Keith Harrison presented and read aloud a letter of endorsement by Curtenius Guard Camp No. 17 for the candidacy of James B. Pahl for the office of National Junior Vice Commander-in-Chief at the upcoming 123<sup>rd</sup> National Encampment. It was moved by Bro. Harrison and seconded by Bro. Lyons that the camp endorse Bro. Pahl as mentioned in the letter. Motion carried unanimously. Copies of the letter were signed by the Camp Commander and Secretary and forwarded to the Department and National Secretaries.

#### XII. Good of the Order:

Bro. Traub will be presenting martial and other old music on a vintage Victrola cylinder record player he brought to the camp after the meeting is adjourned. Bro. Hodges presented five Eagle Scouts with certificates for their genealogical research into their Civil War Veteran ancestors. He & Bro. Peabody will be attending several more ceremonies in the near future. Bro. Lyons attended a day long session of the Sunfield Historical Geneological Society on March 20<sup>th</sup> that was attended by more that 70 people. He spoke to the attendees about genealogical information recovery and the related G.A.R. records after which 40 to 45 people were allowed to tour the hall. Bro. Peabody presented information on a genealogical research website called ancestorplus.com. Bro. Pahl mentioned that the infamous "Teabox Papers" at the Marshall Historical Society are now available for public viewing. Bro. Aves announced Flag Day dinner and presentation will be held at the Michigan

Historical Museum in Lansing on June 14<sup>th</sup> at 6pm in which traditional Civil war era music will be played, military reenactors will be sharing stories about everyday life of the Civil War soldier, and the Civil War battle flags of Michigan will be on display. Information can be obtained by calling (517) 373-1905. Bro. Shumway announced that he and his wife will be in Germany from May 18<sup>th</sup> through June 2<sup>nd</sup> to visit his wife's family.

# XIII. Treasurer's Report:

Bro. Williams reminded the camp that the dues were increased to \$30 at the November meeting. Bro. Williams moved to drop the \$5 January late fee due to the snowstorm induced cancellation of the January meeting and to reimburse late fees already paid. Motion seconded by Bro. Keith Harrison. Motion carried.

Bro. Williams moved, seconded by Bro. Bro. Harrison that the Camp shall pay Helen Edwards Tent No. 30 DUCVW rent for use of the G.A.R. hall. Motion carried with one dissenting vote by Bro. James B. Pahl.

Bro. Williams Treasurer's report showed a balance of accounts as of March 30, 2004 with \$23.40 in checking, \$1775.99 in the Hall Restoration Fund, \$62.98 in the Memorial Fund, and \$1789.25 in savings.

Bro. Harrison moved, seconded by Bro. Lyons to accept the Treasurer's report. Motion carried.
